Meridian Library District Library Board of Trustees are elected by District residents as directed by Idaho Code (IC §§ 33-2720). If you are interested in a board position, please review the Library Trustee **Job Description** for qualifications. Trustee Elections are held in May every odd year (IC §§ 33-2715-2718); candidate filings are due March of that same year. Ada County will make legal notifications for the election, including publishing the notice for petitions for candidacy. Petitions will be filed with the clerk of the district. (IC §§ 33-2722) The county will publish the notice(s) of election.

The Meridian Library Board meets the third Wednesday of each month at 7:00 p.m., online and/or in a conference room at the District's main facility at 1326 W. Cherry Lane. Special meetings are called as needed. Board meetings are open to the public and follow the Idaho Open Meeting Law (IC §§ 72-2) and Trustees adhere to the Idaho Public Records Act (IC §§ 74-1). Trustees are volunteers and are not compensated.

Idaho Code §§ 33-2715. BOARD OF TRUSTEES — SELECTION — NUMBER — QUALIFICATIONS — TERM — OATH — APPOINTMENT OF FIRST BOARD. (1) Each library district shall be governed by a board of trustees of five (5) members elected or appointed as provided by law, who at the time of their selection and during their terms of office shall be qualified electors of the district and if trustee zones have been established under section <u>33-2718</u>. Idaho Code, shall be a resident of the trustee zone. Trustees shall be elected at each trustee election, held on the uniform election date in May. The regular term of a trustee shall be for six (6) years, or until his successor has been elected and qualified. Within ten (10) days after his appointment an appointed trustee shall qualify and assume the duties of his office. An elected trustee shall qualify and assume the duties of his office at the annual meeting. All trustees qualify by taking the oath of office required of state officers, to be administered by one (1) of the present trustees or by a trustee retiring.
